



CHAPERONE GUIDELINES (1 copy per Chaperone)

This sheet must be completed PRIOR to your arrival to the farm. This form will be required at the time of admittance, along with the chaperones signature and the names of the 3 children in their group. CHAPERONES PLEASE READ AND FILL OUR FORM ON SECOND PAGE:

1. Do not unload the children off the bus until AFTER the teacher has completed the check-in at the front gate.
2. One (1) chaperone is required per three (3) children. Chaperone admission is \$11.00 per person, pumpkins are not included for chaperones.
3. The field trip includes: Pig Races, Hayrack ride, Vortex Tunnel, Fun Barn, Petting Zoo, all types of animation throughout the farm, 6 lane Mega Fun Slide, Corn Box, Halloween displays and animals throughout the farm, Pumpkin village & playground, Bengtsonville Play area. Also, included for the children is the choosing a FREE pre-picked pie pumpkin. You will turn in the TOKENS handed to you at the beginning of the trip to the exit when you are leaving.
4. SORRY, the Haunted Barn is not available to any school group, under any conditions. No book bags are allowed in the General Store. One ride ticket for each student comes with admission. Pony Rides are \$5 and can be purchased directly at the Pony Ride tent. There is a weight limit for the pony rides.
5. Each CHILD in the group will receive a TOKEN for their FREE Pie-pumpkin (4-6 lbs.). The token is to be turned in at the exit when your group is leaving. No TOKENS will be issued after the school has paid for their count and has entered the farm. The tokens should be held by the CHAPERONES, the tokens are for students only. **Lost tokens will NOT BE REPLACED.** Choosing the pumpkin should be the LAST activity of your field trip, just prior to your departure. The number of tokens is based on the admittance counts.
6. All children in your group must be nine years of age or younger. If the child is older, general admission prices apply and a pumpkin will not be included. Please note; your rate that you were charged from the school may also have bus fees included, that is not part of the farm school group rate.
7. Any inappropriate or disrespectful behavior will not be tolerated. If any student is found destroying pumpkins or property, the school will be asked to leave and not be allowed to return. Also, the school will be responsible for reimbursement.
8. Please make sure each child attending the field trip has a tag on their shirt/jacket with a contact name & phone number of the lead teacher on the trip in the event a child is lost.
